1)Croesawodd Annette Davies(cadeirydd)bawb i'r cyfarfod/a warm welcome from the chairman.

3)Heddlu—roedd yn braf gweld dwy aelod yn bresennol—Shanice Thomas a Charlotte Carter.Cafwyd adroddiad o'r diweddaraf:damwain methu stopio wedi digwydd tu fas Capel Tabernacl;car yn parcio ar y palmant ble mae'r system draffig ar bwys Ysgol Cae'r Felin;wedi cael galwad fod dau blentyn 14 oed yn yfed alcohol ar y cae chwarae;beic modur ac injan car wedi eu dwyn o dir eiddo rhwng Llanllwni a Llanfihangel.Dyweddodd M.Griffiths fod ceir yn rasio drwy Bontweli bob nos o'r wythnos,ac mae hyn yn digwydd ym Mhencader a Dolgran.Ynghlŷn â'r bachgen welwyd ar cctv yn torri'r gadwyn ar iet y C.Chwarae,ac ar gais yr Heddlu,mae'r Clerc wedi ysgrifennu llythyr at yr unigolyn,i ofyn iddo beidio dod yn agos i'r safle.
