2)Croesawyd PCSO Eleri Morgan i'r cyfarfod.Mewn ateb i'n cwestiwn mis diwetha am fan yr Heddlu'n dod i Bencader—does dim cynlluniau ar hyn o bryd;mae'r ardal yn rhannu fan gydag Aberteifi ac Aberystwyth,ond ar hyn o bryd mae wedi torri lawr.Dywedodd fod pethau'n weddol dawel,er fod car wedi cael difrod gan leidr ar Ebrill 3ydd. Roedd wedi dod â llythyr o ymddiheuriad oddiwrth y bachgen wnaeth ddifrod i fin sbwriel,a'i daflu o gwmpas y C.Chwarae'n ddiweddar.Mae wedi addo ymddwyn yn well yn y dyfodol.Bydd y swyddog yn cadw llygad.Yn anffodus mae graffiti wedi ymddangos yn y C.Chwarae,ac mae'r PCSO wedi siarad â merch am y drosedd.Cafodd wybod gan y Cynghorwyr fod tipio sbwriel yn y Plwyf—allan i hewl Dolgran at gyffordd Rhos,a hewl y mynydd o New Inn;plant ifanc yn chwarae mas ar y ffordd fawr yn ardal Marshlands;plant ar sgwteri mas ar y ffordd yn y pentre; car yn dal i yrru'n y nos yn gyflym ac yn swnllyd dros y glustog cyflymder ar bwys Bro'r Hen Wr.Diolchwyd i'r swyddog cyn gadael.It was good to have police presence in the meeting.The police van we enquired is off the road at the moment being repaired.A car has been damaged by thieves on April 3<sup>rd</sup>.The boy who damaged a rubbish bin,and threw it across the Play Corner has written a letter of apology to this Council,stating that he will behave in future.The officer has promised to watch the area.Unfortunately,another incident has happened with a girl causing graffiti on one apparatus,and the PCSO is dealing.A great deal of money has been invested in the Play Corner,and the site should be respected by all.The PCSO was told of various concerns by Councillors—fly tipping in the Parish,young children playing out on the main road near Marshlands;riding of scooters on the road in Pencader.A driver persists in speeding over the speed cushion near the Green House at night.The PCSO was thanked before leaving the meeting.

c)Cyfleusterau Alltwalis:Rhys Davies wedi anfon e-bost i ddweud fod y safle wedi ei gwella gan y C.Sir,a'u bod yn credu nawr fod y lle'n foddhaol.Bydd y Cynghorwyr yn cwrdd yno nos Fawrth Mai 29ain/The County Council now think that they have brought the site of Alltwalis toilets to a satisfactory standard; members will visit the site on 29/05 for inspection.

ch)Goleuadau stryd-mae'r Clerc wedi bod o gwmpas y 4 lleoliad lle y gofynnwyd am oleuadau newydd gyda'r swyddog Arwel Price.Yn anffodus nid yw yn bosib rhoi goleuadau newydd yma ar hyn o bryd/the Clerk has been out to sites with Arwel Price(street light section),but at this time its not possible to supply new lighting.
