

222)Cyngor Cymuned Llanfihangel-ar-arth / Community Council: Cyfarfod Misol / Monthly Meeting, Nos Lun, Medi 18fed, 2023, - 18/09/2023 — 8.00 pm at Tabernacle Chapel Vestry, Pencader.

Cynghorwyr yn Bresennol /Councillors Present: M.Griffiths, A.Davies, H.Lewis, S.Mason, R.Thomas, G.Jones.

1) Cadeiriwyd gan M.Griffiths. Croesawodd bawb, a nodwyd ymddiheuriadau. Darllenwyd llythyr oddi wrth C.C.Mair Jones, yn datgan ei ymddiswyddiad o'r Cyngor, a hynny oherwydd ei bod wedi symud o ardal Pencader. Bydd llythyr o ddiolch yn cael ei anfon, yn diolch iddi am ei gwaith caled ar y Cyngor. Meeting chaired by M.Griffiths who welcomed all and apologies noted. A letter was read from C.C. Mair Jones resigning from the Council as she has moved recently from the area. A letter of thanks will be sent, in appreciation of her hard work as Councillor.

2) Datgan diddordeb gan Gynghorwyr/declaration of interest/none.

3) Heddlu: Neb yn bresennol. Derbyniwyd y data misol. The PCSO was not present. Monthly data received.

4) Cofnodion Mis Gorffennaf / July minutes - found to be correct — prop.A.Davies, sec. S.Mason. Bu cyfarfod ar Orffennaf 25ain i dderbyn gwaith oddi wrth y Cyfrifydd cyn ei anfon at Audit Cymru / Councillors met on 25th July to receive accounts from our accountant ready for Audit; passed as correct: A.Davies prop. and S.Mason sec. All agreed. Clerk confirmed delivery of accounts to Wales Audit Office at Penlle'rgaer-31/07/23.

5) Materion y Clerc / Clerk Matters:

a) Cyngor Sir: atebion oddi wrth yr Adran Briffyrdd / Responses from Highways Department:

(i) Anfonwyd llythyr o ddiolch i'r Adran oddi wrth y Cyngor, yn diolch am y gwaith safonol sydd wedi ei wneud ar y ffordd ym Mhencader /the Council has sent a letter thanking the County Council for re: surfacing part of the road in Pencader. The County Council has responded.

ii) Toiledau Pencader: dim diweddariad ond fod y swyddog ddaeth i gwrdd â'r Cynghorwyr mis Mehefin wedi bod i ffwrdd o'i waith yn sâl; dydy'r Cyngor Sir ddim wedi trefnu glanhawyr i wneud y clirio ar ôl gweithwyr; no up-date on Pencader Conveniences — the Officer who met with Councillors in June has been absent from work; no cleaning has been undertaken at the site following the work of electricians, etc.

iii) Cafnau blodau: Farnyard wedi eu chwynnu ddwywaith; Clerc wedi rhoi diolch yn Clecs i'r unigolion sydd wedi dwrhau drwy'r haf; flower troughs — have been weeded twice during the season; Clerk has thanked the individuals who have watered the troughs throughout the summer, in Clecs.

iv) Cofeb yr Hen Ŵr — A. Lewis yn gobeithio dechrau ar y gwaith yn fuan / A.Lewis hopes to start repairs to the Old Man of Pencader's Memorial soon.

v) Defibrillators - rydyn wedi gofyn i unigolyn o Brechfa i gymeryd gofal o'r defibrillators yn ein Plwyf. Mae wedi cytuno ar ôl i'r Cyngor dderbyn — cynigiodd R. Thomas ein bod yn derbyn ei wasanaeth, eiliodd A.Davies ac roedd pawb yn gytûn. Bydd un yn cael ei osod yn Windy Corner, ac un arall yng nghysgodfan bws New Inn.

223) Materion: Diolchwyd i H.Lewis am fynd o gwmpas y Plwyf gyda'r unigolyn. We have approached an individual from Brechfa to take over the maintenance of our defibrillators. R. Thomas proposed that we accept his services, A. Davies seconded and all agreed. Councillors wished to thank H. Lewis for showing him around the Parish. We have defibrillators to place in Windy Corner and New Inn bus stop.

vi) Toolkit i Gynghorau — Derbyniwyd y dair adran gyntaf fel arolwg trylwyr o sefyllfa'r Cyngor Cymuned a nodwyd y materion sydd angen gweithredu arnynt. The first three sections were accepted as a detailed positional statement and action points were noted. A.Davies proposed and H. Lewis seconded.

vii) Gwaith i'w wneud ar Fynwent Pencader: torri'r coed o gwmpas yr Ardd Goffa a phlannu ffawydd yn eu lle — hysbysebu yn syth/work to be carried out at Pencader Cemetery — will be advertised immediately — taking down the trees around the Remembrance Garden and replacing with beech. Hefyd angen gwella darn gwaelod arwynebedd y llwybr — bydd y Clerc yn gofyn am brisiau/The lower part of the Cemetery path is crumbling and needs resurfacing. The Clerk will request quotes.

viii) Mae dogfennau claddu newydd ar gael nawr i'w rhoi i ymgymerwyr angladdau cyn cael mynediad i'n Mynwentydd. Diolch i H. Lewis am ddod â chopiau. Cynigiodd R. There are new burial regulations which Funeral Directors have to discuss with families, and fill in information, prior to entering Cemeteries. H. Lewis provided copies of the forms. She was thanked. R. Thomas proposed that the Council utilizes these forms, A. Davies seconded and all agreed.

Hewl fach ochr draw Glanawmor Uchaf allan i Faescader — nifer o

gerbydau yn gyrru ar hon er taw llwybr cerdded yw hi. Angen arwydd 'Dim Mynediad' ar y ffordd. Bydd yr Heddlu yn cael gwybod / cars travel up the path opposite Glanawmor Uchaf towards Maes Cader. This is a footpath. We will request a 'No Through Road' sign, and inform the PCSO.
