Cyn dechrau'r cyfarfod misol cawsom gyfle i wrando ar Mr. Wayne Jones, swyddog o gwmni Openreach yn siarad am gynlluniau y cwmni i ddarparu rhwydwaith band-eang ffibr yn yr ardal hon. Mae angen i ragor o bobl hawlio talebau i sicrhau bydd y system yn cael ei uwchraddio. Cytunwyd i ddsbarthu ffurflenni i blwyfolion er mwyn tynnu eu sylw at y mater holl bwysig yma a'u hannog i ymateb.

Before the monthly meeting the Chairman welcomed Mr. Wayne Jones, a representative from Openreach who had come to discuss the company's plans to provide faster broadband through fibre in this area. It is paramount that more people apply for vouchers to ensure sufficient interest if the system is to be upgraded in our community. It was agreed to distribute leaflets to parishioners to draw their attention to this matter and encourage a greater level of response.

Matters Arising: <i>(i) <u>Carmarthen County Council:</u> Highways Department has confirmed receipt of our latest concerns and will carry out improvements.</i> <i>(ii) <u>Pencader and Alltwalis Conveniences:</u> Cleaning: an offer has been received from Alltwalis to place an advertisement for a cleaner on the village's WhatsApp. A cleaner is required for 5 hours a week. A salary rate of £12.21 per hour was agreed. It was noted that the County Council will cease cleaning in Alltwalis at the end of June.</i> <i>Prior to moving ahead with this matter, it was agreed to contact One Voice Wales for advice to ensure this is acceptable.</i> <i>Pencader Conveniences cleaning - we will initially advertise on the village's Facebook page (salary scale as above). At the last meeting in May, it was suggested that we look at coin machines for all doors on both sites, but this has proven to be very expensive.</i> <i>(iii) <u>Parish Cemetery, Pencader:</u> the slabs placed in front of one grave to hold more flowers have been removed. It will now be easier for the groundsman to mow the grass.</i> <i>(iv) <u>Data back-up:</u> A. Davies will assist the Clerk with saving data on the external hard-drive.</i></p>
